This contract is for approximately a 6 ft. space at the cost of \$30 per month, for three months, to be paid in full (\$90) at the time of signing. I agree to also pay a 25% commission of my sales to Gallery 35, along with a 3% fee for credit card sales. I am a current member of DWS.

This contract is for approximately a 36" space at the cost of \$15 per month, for three months, to be paid in full (\$45) at the time of signing. I also agree to pay a 25% commission to Gallery 35, along with a 3% fee for credit card sales. Same rules as shows will apply except that any art cannot exceed 32" in width including the frame. Larger pieces of art are acceptable if it is vertical in presentation due to limited wall space. I am a current member of DWS.

GALLERY 35 REGULATIONS

1. The Exhibit Committee will determine the number of pieces to be displayed and the location.
2. Shifts will be determined each exhibition and required of all artists, which is four and a half hours per shift. **THIS IS A REQUIREMENT TO PARTICIPATE IN GALLERY 35. An artist must do the required shifts or be subject to removal from the Gallery.**
3. There are no limitations on the age of the transparent watercolor paintings.
4. All transparent watercolor paintings must be wired, tastefully framed, and ready to display. The Exhibit Committee may refuse to accept any painting that does not meet this requirement.
5. Reading training materials at the gallery is required of all participants to learn the use of credit card sales and other vital information in running a smooth business.
6. Payments to artists for sales (minus 25%, and 3% on credit card sales) will be settled at the end of each month. Immediate payment is not available.
7. All artwork in Gallery 35 will be sold through the gallery and not through side sales.
8. The hours of the gallery will be Thursday, Friday and Saturday, 10:00 a.m. to 5:00 p.m.
9. When a painting is sold, a replacement is required.
10. Layaway sales must be approved by the individual artist. No art can be taken until full payment is received.
11. The Gallery 35 Contract, DWS Requirements for Shows and Exhibitions, DWS Framing Guidelines, DWS Guidelines for the Gallery 35 Art Bin must be adhered to or the art will be removed and the artist notified.
12. Permission is given to use images of artwork for promotional purposes.
13. This contract is valid until such time as there are changes or modifications to the contract and as long as the artist continues to participate in the exhibition. A new contract must be signed if the contract is changed or modified or if the artist does not participate in an exhibition cycle.

RELEASE OF LIABILITY STATEMENT

The DWS does not provide security or insurance other than the alarm system installed in the building. DWS is not responsible for damage or loss. I will not hold the DWS, Basix Management L.C., or Arts to Zion L3C responsible for any loss or damage to my artwork.
