- All artworks must be current in the past two years and not previously shown in the DWS shows.
- Only **ORIGINAL TRANSPARENT WATERCOLOR** paintings will be accepted. The work must be original, from your own photo or design.
- The DWS Show Committee reserves the right to deny entry based upon the quality of framing, non-application to the theme and/or appropriateness for family viewing and use of transparent paint.
- Participation in the show gives permission for DWS to use an image of artwork for advertising purposes.
- All art must be available for sale. Buyers can use cash, check, or credit card. Ideally, the painting should remain on the walls for the duration of the exhibit. See chairperson for exceptions.
- **Name, address, title and price of painting must be mounted on the back of the painting.**
- Artwork **must adhere to the DWS Framing Requirements** and it's important for you to review them. WIRED HANGING SYSTEM ONLY.

Release of Liability Statement: Security or insurance is not provided by DWS, Gallery 35 or its officers. I agree that I will be fully responsible for all damage or loss to my artwork on display during the show. I will not hold the DWS, Gallery 35 or any person associated with groups, responsible for any loss or damage to my artwork.
